How to create an RFP under ITES-3S

1. Develop RFP.
2. Log on to CHESSE IT e-mart site: <https://chess.army.mil>. Create user account, if first-time user.
3. Hover on RFX tab on the screen, to create an RFP. Only a Contracting Officer or Contract Specialist may create an RFP.
4. Select 'Create' under RFP Services menu.
5. Select a Task Order from the drop down menu.
6. Select ITES-3S from the drop down menu and the contracts (vendors) to receive RFP. The ordering contracting officer will issue a proposal request to all contractors, unless a SB set-aside has been documented.
 - Enter general and specific proposal information, as requested.
 - Click Submit button to submit RFP.
7. Once the RFP is submitted click on 'Pending Review' to view. The RFP will be sent to CHESSE Gate Keeper or the Army Application Migration Business Office (AAMBO) depending on the contract vehicle selected. Upon review, your RFP will either be released to the vendor(s) for action "Open" or administratively canceled. ****Note: RFP's will not be visible to the vendors until the gatekeeper accepts the RFP submission.**
8. E-mail will be sent to you when:
 - RFP has been approved and posted on the CHESSE portal.
 - Each vendor receives an email alerting them of the RFP.
 - Proposal has been submitted IAW the RFP instructions.
9. Issue Award.
